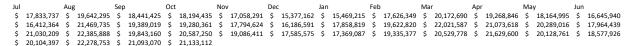


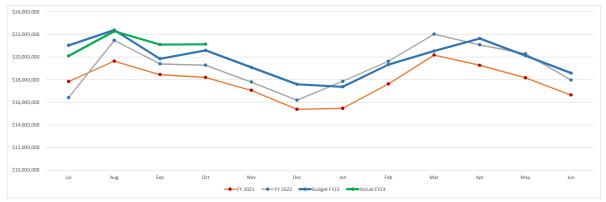

Northeastern Local School District General Fund & Related Fund Balances Variance Report October 31, 2022

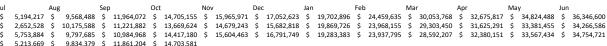

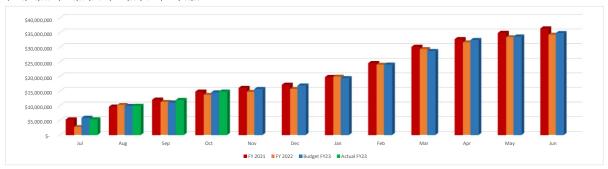




Northeastern Local School District General Fund & Related Fund Revenues Variance Report October 31, 2022

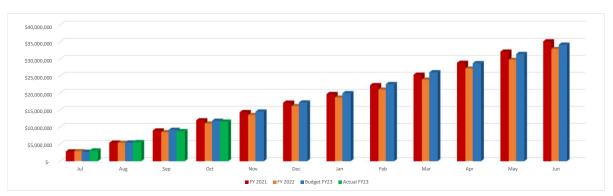

Notes

Revenues

- 1.01 and 1.02 Property Tax final settlement will occur in August; the August report shows tax collections are 158,320 (2.8%) below budget. Line 1.05 Property Tax Allocation is the Rollback and Homestead related to the tax settlements, the state moved this payment in September and the budget is reflected in October. We have budget \$940,578 and received \$875,830 or \$64,748 (6.9%) under budget. Both revenues sources should be recaptured in the Spring.
- 1.03 Income Tax Reflects a \$337,622 over budget, this reflects a 16.7% increase over the same quarters as FY2022. The Income Tax reflect collections in July, August and September 2022. The income tax will need to be carefully evaluated with the economy.
- 1.035 and 1.04 Unrestricted Grant (Line 1.035 State Aid, Line 1.04 Restricted) in combination was over budget by \$7,243. The October Funding Formula has the actual numbers and we will audit the numbers through our EMIS (Student Records). NELSD was not to receive less funding in FY22-23.

Line 1.06 Miscellaneous Revenue is 6.9% or \$34,156 over budget and look in line with the annual budget.

Total Revenues is currently 2% over budget or \$286,401.

Expenditures

- 3.01 & 3.02 Wages and Benefits are 4.3% under budget.
- 3.03 Purchased Services are now under budget and we will watch these as we progress though FY2023. The Tuition expenditures similar to the revenue will need review the actual student counts. We will carefully watch the utility expenditure at the new Northeastern Pre-K 12 Building.
- 3.04 Supplies are over budget for annual expenditures Edmentum, MVECA software, and Curriculum have expenditure higher than budget early in the school year carryover expenditures for the ELA curriculum accounts for most of the expenditures.
- 3.05 Capital Outlay –We are waiting on 4 buses, now expected in December

Total Expenditures are \$259,461 under budget or 2.2%. We are start to see the expenditures being impacted by the economy and we will need to carefully monitor the expenditures.

Summary – October Report reflects a monthly report that is very similar to the five year forecast, we should add \$500,000 to our reserves. The administration will closely monitor the expenditures as we move forward.

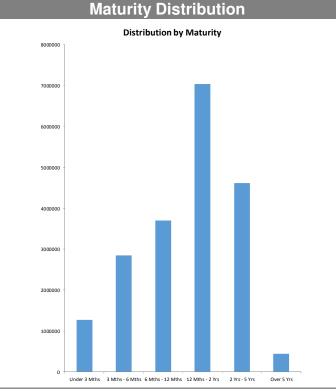

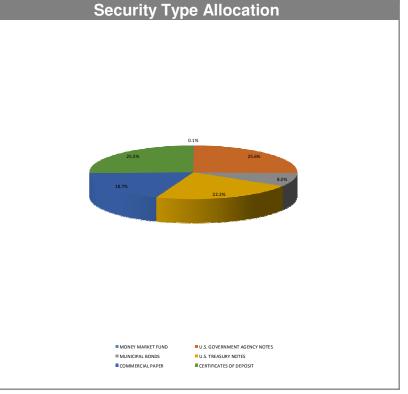
